CONSULTANCY AND SUPPORT FOR COMMUNITIES

ANOLF wants to propose an innovative single consultancy service in the regional territory essentially based on two intervention plans:

- Development of a network of professional figures specialized in the various sectors that the reference case studies recall.
- Construction of a system of "good practices" with the institutional subjects involved, in order to facilitate and make more effective the comparison with the reference users.

This service, inspired by a private-solidarity principle in the relationship with users-customers, aims to be an informative and legal point of reference in the regional territory.

- Consultancy and support for entrepreneurs in issuing entry visas and in managing the employment of foreign and EU citizens; issuing of visa for entry for self-employment; issuing of entry visa and management of stay for work in particular cases art. 27; issuing of entry visa, hiring and administrative assistance of housemaids, etc.
- Orientation to social-health services, reception facilities.
- Promote Italian language and culture courses, employment support services.
- Support for the recognition in Italy of qualifications obtained abroad.
- Support to facilitate foreign prisoners in resolving their integration problems, in the appropriate offices of the prison in the region.

- Support in filling out the financial support application form.
- Accompanying service at local institutions.

RIGHTS PROTECTION SERVICE

- Assistance and representation in proceedings before ordinary and administrative judicial bodies.
- Preparation of LEGAL MEMORIES pursuant to art.10 bis Law 241/90 at the Police Headquarters.
- Advice and assistance in problems of both a civil nature (compensation for damages, separations and divorces, etc.) and of a criminal nature, with particular reference to problems connected to the penitentiary stay of a family member.
- Consultancy and assistance in relations with the various Italian consular representations abroad regarding legalization and issuing of special powers of attorney.

INTERCULTURAL LINGUISTIC MEDIATION SERVICES

- Offer interpreting, linguistic-cultural mediation and translation services in support of the Territorial Commissions for the Recognition of International Protection and for the National Commission for the Right of Asylum as well as for the Court, for the Regional Health Service and for the Social Services of Municipalities of the Region.

LISTENING POINT SERVICE

- Aimed at women, men and their families in educational and school settings and as help against mistreatment and violence only in the Udine and San Giorgio di Nogaro offices.

ANTIMOBGING LISTENING POINT SERVICE

- Offer a listening, support and protection service for women and minors.
- Prevent and combat violence.
- Offer counseling and psychological support.
- Legal advice and support for victims of violence with pedagogical support interventions.

DEVELOPMENT COOPERATION SERVICE IN SOMALIA

Anolf is making its first experiences in the field of development cooperation in Somalia in the "Saving the new generation" project financed by the FVG Region with the aim of:

- improve nutrition, supporting the village's agro-ecological activities.
- strengthen the agro-pastoral skills of women and young people.
- promote self-sufficiency and food security of the population in the village.
